Application

Complete the application in full and read all terms and conditions. Be sure to include the required description and photos, if applicable; note that photos will **not** be returned. Sign the application, keep a copy for your records, and mail the original with your non-refundable application fee to the address listed above. **DO NOT SEND BOOTH FEES; FEES WILL BE COLLECTED IF ACCEPTED.**

Product Requirements

- All products must be handmade or embellished in the United States or Canada by the applicant using original and creative designs. NO COMMERCIAL, MASS-PRODUCED, MANUFACTURED, OR IMPORTED products are allowed.
- The artist must be present at the Crafts Faire.
- Only items listed on the application and approved may be sold. You will be asked to remove any items from your booth that were not juried and approved. Failure to comply will result in being asked to leave the Faire.

Booth Size & Placement

All booths are 12 feet deep x 10 feet wide. Booth assignments will be made after jurying, exhibitor acceptance, and as booth fees are paid. Note: This is an outdoor event. Prepare your booth accordingly. *No refunds will be given due to inclement weather.*

A limited number of corner and double corner spaces are available for an additional \$75 or \$125 respectively. Indicate your request for a corner or double corner space on the application.

First Time Exhibitor

To encourage new exhibitors at Vintage Days, a first time discount of \$50 is given to accepted new exhibitors.

Recruit an Exhibitor

To encourage our longstanding exhibitors to recruit new exhibitors for Vintage Days, a discount of \$50 for each exhibitor recruited is given. To be eligible for the discount, the recruited exhibitor must be a new to the Faire, list the name of the exhibitor recruited by on the application, and be accepted. The discount of \$50 is applied to the booth fees for the following year; maximum total discount of \$250.

Returning Exhibitor

To honor the commitment of our longstanding exhibitors, we offer a \$25 discount **for every five (5) years that an exhibitor has been accepted and attended the show beginning in 2010.** Note, current application year (2022) not counted; maximum total discount of \$250.

Gourmet Food Exhibitors

Only pre-packaged foods are allowed; single servings intended for on-site consumption are not allowed. If accepted, gourmet food exhibitors are required to complete the Fresno County Community Event Food Vendor application and pay the associated \$47 fee. Vintage Days will collect the application and fees and submit to Fresno County.

Security

Overnight security will be present; however, Fresno State and Vintage Days will not be responsible for lost, stolen, damaged, or misplaced items. We encourage all exhibitors to remove items of value from their booth each night.

Confirmation

After all applications have been juried, all exhibitors will receive an **EMAIL** of acceptance or non-acceptance. Booth fees must be received no later than two (2) weeks after notification is sent.

Cancellation Policy

A processing fee will be assessed for all exhibitors who withdraw from the Faire. Cancellations six (6) weeks prior will be assessed a \$50 fee; four (4) weeks prior will be assessed an \$85 fee; less than four (4) weeks prior to the Faire will forfeit all application and booth fees.

Generators/Electricity

Generators are prohibited and may not be used. Failure to comply will result in being asked to leave the Faire. A limited number of spaces with access to electrical outlets are available. Spaces are given to those that require electricity for the products sold and not for aesthetic purposes or to power technology (i.e. laptops, credit cards machines, etc.)

Pets

Pets or animals of any type, other than service dogs, are not allowed at the Faire

Parking

Exhibitors will be issued a parking pass by Vintage Days. Passes must be displayed on vehicle dashboards at all times. Exhibitors wishing to park overnight in a motor home, trailer, van, or other vehicle in campus parking lots are required to pay a \$10 fee per night to the University Parking & Transportation Office. Exhibitors are responsible for making these arrangements by calling 559.278.2950. Disabled parking stalls and red zones will be enforced by campus police. Metered parking is enforced during the weekdays and relaxed during the weekend. Parking in all other lots will be relaxed Friday through Sunday.

Vintage Days Crafts Faire Tent Certification Requirements

**** NEW FOR 2022 ****

In order to comply with State Fire Marshal policy, Fabric Certification and Labeling for SMALL Tents: CCR, Title 19, Division 1, ***all exhibitors shall have a tent that meets the following requirements.***

Fire Marshal personnel will be on-site to check for certification prior to the opening of Vintage Days.

Small tents shall have a permanently affixed label bearing the following information as specified in CPAI-84.

- 1) Certification - A statement that the materials used in the manufacture of the item meet the flame resistance requirements of CPAI-84.
- 2) Manufacturer Identification.
- 3) Warning label stating the following: Warning, Keep all flame and heat sources away from this tent fabric. This tent is made with flame resistant fabric which meets CPAI-84 specifications. It is not fireproof. The fabric will burn if left in continuous contact with any flame source. The application of any foreign substance to the tent fabric may render the flame resistant properties ineffective.

The label below is a sample of what is most often found on tents from large retailers and complies with the policy.



This item is made with flame resistant fabric that meets CPAI-84 Sec. 6/ULCS109, NFPA 701 fire standard specifications. **IT IS NOT FIRE PROOF**
The fabric will burn if left in continuous contact with any flame. The application of any foreign substances to this fabric may render the flame retardant properties ineffective.

Vintage Days Crafts Faire Liability Insurance

According to Executive Order 829, the California State University Office of the Chancellor requires all exhibitors to show evidence of adequate liability insurance coverage by furnishing to the University a certificate of insurance that includes additional insured endorsements. Because of the nature of the Vintage Days Crafts Faire, the University Risk Management Office has agreed to make exceptions to this requirement.

As such, once applications are submitted, each application will be reviewed by the University's Risk Manager to determine, based on the products to be sold, if a certificate of insurance will be required. Most products offered for sale during the Vintage Days Crafts Faire will fall into the category of *little risk* and the insurance requirements will be waived.

Certificates do NOT need to be obtained and sent with the initial application. If any exhibitor's products are determined by the University's Risk Manager to be a greater risk, those exhibitors will be notified and will be required to provide a certificate of insurance as described below.

It is suggested that all exhibitors submit an application as soon as possible to ensure any issues relating to insurance are resolved in a timely manner.

Insurance Requirements:

Business or homeowner's insurance is acceptable as long as all certificates of insurance include the following:

- Provide for thirty days advance written notice to the University of cancellation of any of the insurance coverage
- Provide for Acceptability of Insurers rating, AM Best – AVII or equivalent unless otherwise agreed by the University
- Name the State of California, the Trustees of the California State University, the campus and the officers, employees, volunteers and agents of each of them as additional insureds, except for professional liability and workers' compensation insurance
- General Liability: comprehensive or commercial with minimum limits each occurrence \$1,000,000; General Aggregate \$2,000,000
- Workers' Compensation: as required under California State law

 - One (1) photo of your studio, workshop, or workspace showing the product being created, supplies, and tools
 - One (1) photo of the product at half completion
 - One (1) photo of completed product(s)
 - One (1) photo of your booth showing display of product(s)

Name must be written on the back; photos submitted become the property of Fresno State Vintage Days and will not be returned.

RETURNING 2019 EXHIBITORS ONLY::
