 If this is an emergency, please find a safe place and call 9-1-1.

**CONFIDENTIAL RESOURCES**

I want support and/or to talk with someone about the incident or my options **confidentially**.

**Victim Advocate, 559-278-6796**  
 Crisis Intervention, resources, referrals, housing/academic assistance.

**Counseling & Psychological Services (CAPS), 559-278-2734**  
 Crisis Intervention, therapeutic and counseling services, resources and referrals.

**EVIDENCE COLLECTION**

I want medical evidence collected (i.e. rape kit) for support in a criminal complaint.

**Forensics Nurse Specialist of Central CA (FNSSC), 559-324-9100**  
 Offers Sexual Assault Forensic Exams (S.A.F.E.) in a small clinic without reporting to law enforcement or Title IX.

**Community Regional Medical Center (CRMC), 559-459-6000**  
 Offers Sexual Assault Forensic Exams (S.A.F.E.). Law Enforcement will be notified. You have the right to refuse any part of the examination.

*Evidence should be collected ASAP after assault, preferably within 72hrs, although it can be collected up to 5 days after the assault. A medical exam does not commit you to report to the police but is strongly recommended if you're considering reporting to the police. Transportation can be provided by law enforcement.*

**MEDICAL CARE**

I want treatment for physical injuries or **medical care**.

**Student Health and Counseling Center (SHCC) 559-278-2734**  
 The SHCC can check your physical health, check for STIs, offer emergency contraception.

- and/or
- Hospitals
  - Urgent Care
  - Private Physician

*Preventive medications should be started ASAP after assault, preferably within 72hrs, although emergency contraception can be taken up to 5 days after the assault.*

**REPORTING**

I want to report the incident.

**Anonymously**  
 No investigation or disciplinary action will ensue from this report.

**Confidentially, 559-278-6796**  
 With this option, you can report it to the Victim Advocate on campus who can discuss options and provide resources.

**University/Title IX, 559-278-2364**  
 Filing a Title IX complaint may result in an investigation and disciplinary action through the University for the alleged perpetrator.

**Law Enforcement, 559-278-8400**  
 This process may start an investigation by the police department that could result in charges brought against the alleged perpetrator.

**ACADEMIC STRUGGLES**

I want to change classes or am struggling academically.

Reporting to one individual is not mutually exclusive from reporting to another individual. Choosing one route does not preclude or exclude other options. The student can speak with multiple groups and pursue multiple actions at the same time.
