

1. Who is eligible?

- ✓ You've completed at least one term at a CSU campus as a matriculated student in a state-supported program (CGE and Certificate programs not eligible) and earned at least 12 units at that campus. Incoming transfer students are now eligible! GPA requirement is the same (2.0 transfer GPA).
- ✓ Your GPA is at least 2.0 at your campus and you are in good standing.
- ✓ You are or will be enrolled at your campus during the time you're taking a fully online class through another CSU campus.
- ✓ You've **paid** all your tuition as a full-time student or have a fee deferment.

2. Can the course I take at another CSU forgive my failing grade at Fresno State?

- a. No. Fresno State does not allow courses taken at another institution to be eligible for grade forgiveness. See general catalog for more information.

3. What fees are required?

- a. Students must have PAID full-time tuition or have a fee deferment in order to be eligible. If they do, then no additional systemwide tuition fees are charged. However, non-resident tuition is in ADDITION to applicable systemwide tuition and must be paid to the host campus offering a Fully Online Course.

4. When will my grades come in? Do I need to send a transcript?

- a. Grading deadlines are set differently at each CSU, so it's best to check in with them individually. You do not need to request an official transcript be sent. Each campus has a process that automatically receives grades to post your transfer credit at the end of the term.

5. What is the SPEC 125 class?

- a. If you are enrolled in a CSU Fully Online course, you will see a course on your record titled "SPEC 125". It is important you do not drop yourself from this course. This tells your home campus that you are enrolled in classes outside of Fresno State and generates the process to receive your grade and transfer credit at the end of the term. This course gets removed from your record once your transfer credit has posted.

6. What if I want to drop a course and I'm not in Fresno?

- a. To drop a CSU Fully Online course, you'll need to request the drop from the Host Campus.
- b. If you are a host student at Fresno State, contact the [Office of the University Registrar](#) and we can explain the process to you.

7. What happens if I drop below full-time at my home campus? Can I keep my CSU Fully Online Class?

- a. Students can drop below full-time and stay in the CSU Fully Online class. Be aware full-time fees are required for participation in the program.
- b. If you are receiving Financial Aid, dropping units could impact your eligibility. Contact the Financial Aid Office for more information.

8. What if I'm a Fresno State student who wants to drop my fully online course at another CSU?

- a. To drop a CSU Fully Online course, you'll need to request the drop from the Host Campus. All students must follow the drop deadlines and procedures of the host campus. Contact their Registrar Office for more information.

9. When can I add a CSU Fully Online class?

- a. Adding dates vary campus to campus. It's best to check with the campus using the csufullyonline.com website and viewing the courses. You can also view the course information in your Student Center.

10. How many CSU Fully Online classes can I take per semester?

- a. The maximum is one course per semester. Exceptions can be made, reach out to your home campus' Registrar Office for more information.

11. Are international students eligible to participate in Fresno State's CSU Fully Online classes?

- a. Yes, only if it is approved by the Fresno State International Office. Contact the Office of the University Registrar to inquire.

Special Note: Financial aid is available only through your home campus. If you're eligible for veterans, rehabilitation, Social Security and other federal, state or county benefits, you must secure eligibility certification from your home campus.
